As of February 2025, the APTA-Orthopaedic Board of Directors has signed a memorandum of agreement formally recognizing our collaboration with Athletes and the Arts (AATA).

Athletes & the Arts (AATA) is a non-profit coalition of sports medicine, performing arts medicine, and other wellness organizations focused on performing artists. There are currently over 20 organizations contributing to the Athletes & the Arts mission of "integrating science of sport and the performing arts for the mutual benefit of both."

A collaboration between the APTA Orthopaedic - Performing Arts Special Interest Group (PASIG) and AATA not only helps provide value to PASIG's members, but also supports the APTA-Orthopaedic vision - to be a world leader in providing resources to optimize movement and musculoskeletal health.
